The physical shares currently listed under the Promoter category belong to relatives of the First Generation of the C.J.Gelatine Products Limited. 4. Crucially, these specific shareholders are not traceable and the Company has been unable to establish contact with them despite multiple attempts following the mandatory dematerialisation process. *Request for Action* Given that these specific shareholders: Have physical shareholding allotted in 1985. Are untraceable and in a state of no-contact for a considerable period. Do not actively participate in the Company's management or operations. Therefore, we are unable to compel the dematerialisation of these shares. Hence, we respectfully request the Exchange to provide a suitable solution.
